Abstract

The abstract of the text to be submitted should not exceed one page A4. The text will be written in French or English with Times New Roman size 13 and 1.5 spacing, justified. The title of the abstract will be written in bold with capital letters (Times New Roman, size 14). The names of the authors of the article (Times New Roman, size 12), please point out the name of the author presenting the work. The author addresses should be written in italics (Times New Roman, size 10, indicating the e-mail address of the author presenting the work. The references must be indicated at the bottom of the page and their corresponding numbers should be written in brackets in the text.
